Tuition payment terms:

• The Village Schoolhouse charges an <u>annual tuition for the school year, which is divided</u> <u>into 10 monthly payments.</u> Tuition payments are due in full each month regardless of attendance, vacations, family emergencies, school closure, holidays, student illness, etc. School closure days due to weather or power outages are not made up.

Due by June 1, 2024(or when registering if after this date)	A non-refundable June 2025 deposit equal to one month's tuition.
Due by August 1, 2024(or when registering if after this date)	Payment #2: A non- refundable May 2025 deposit.
Payment #3-#10	Due on the first school day of each month from September 2024 through April 2025. Payments made in June and August are not refundable even if you withdraw your child before the beginning of school.

 If your child is withdrawn before the end of the school year, a withdrawal form must be completed and submitted. Thirty days' written notice must be given by the first day of the month in which the withdrawal will occur. If you fail to give such notice, you are liable for the full month's tuition regardless of whether your child no longer attends the school or only attends for part of the month. Additionally, withdrawing your child before the end of the school year results in the forfeiture of the May and June 2025 tuition deposits. THERE ARE NO EXCEPTIONS TO THIS RULE.

- Consider your schedule carefully. Once you have registered, if you decide to <u>reduce</u> your schedule, you must:
 - Give thirty days written notice by the first of the month.

(Your prepaid May and June deposits <u>will not be reduced to reflect a schedule reduction and</u> <u>your child's attendance for May and June will be based on their most current schedule.)</u>

- Please carefully read your contract and your parent handbook.
- Registration at the school implies agreement with our policies and philosophy. If you need clarification on any issues, please speak to Ms. Meg directly.
- Unfortunately, we are unable to offer conditional registration. If your child is not ready to attend school by your scheduled start date for toileting or other developmental reasons, parents have the following options:
 - You may pay tuition to hold your child's enrollment, or
 - 30-days notice prior to the first payment, send written notice of withdrawal from school, but we will hold your registration and last month deposit for the next available opening during the current school year (cannot be applied to next school year.)
 - You may withdraw from school as described in the contract.
- Monthly tuition is due on or before the first day of the month. A \$20.00 late fee will be charged on payments received after the fifth of each month. Additionally, there is a \$35.00 handling fee for any returned check. Finally, interest on past due balances is 1.5% per month.
- Submission of an application (including the return of this contract) does not guarantee enrollment.
- The Village Schoolhouse reserves the right, in its sole and absolute discretion, to revoke enrollment when it deems it necessary. This includes revocation of enrollment after a student has already begun attendance. The revocation of enrollment by The Village Schoolhouse does not guarantee a refund of any deposits paid.
